## TOURNAMENT RULES - PLEASE READ CAREFULLY

1. All entrants must be in good standing with the Central New York USBC & National USBC with current 2025-2026 membership card. (Rule 301b, USBC).
2. Age as of November 1<sup>st</sup>, 2025 will determine the age group in which the bowler must participate.
3. The tournament will be a three (3) game singles event, 4 bowlers on a lane (no more than 5, should the schedule require).
4. Averages:
  - a. Participants may enter only one time. Entrants shall use their highest league average of the 2024-2025 season. If entrants do not have a previous winter average, the highest average with 21 or more games as of the 2025 summer season will be used. If no summer average, current league average with at least 21 games as of November 1<sup>st</sup>, 2025. Current averages must be verified in writing by the league secretary. All others will bowl scratch.
  - b. Bowlers are responsible for verifying their own average. Please refer to USBC Rule 319a-3 regarding the reporting of incorrect averages.
  - c. USBC Rule 319a-2 regarding the 10-pin provision will be waived.
  - d. USBC Rule 319d regarding prize winnings reporting will be waived.
5. Handicap will be based on 75% of 200. Participants with a 200+ average will bowl scratch.
6. Entrants will report 30 minutes before scheduled time to bowl.
7. A bowler arriving late may bowl, but her score will begin from the frame in progress.
8. In the event a bowler cannot finish her series, zero pins will be scored for the remaining frames.
9. No entry fee will be refunded. Entries close on November 2nd, 2025.
10. Replacement bowler will be permitted (preferably in the same class).
11. Handicapped bowlers requiring aids such as a crutch, cane, wheelchair etc., must report in writing by November 2<sup>nd</sup> so that special consideration can be arranged.
12. Any claims for errors in scoring or calculations must be filed with a tournament official no later than 2 hours after completion of the block.
13. Cash prizes will be returned 100% and awarded on a handicap basis, at least one for every five entries.
14. Any protest must comply with USBC rule 329.
15. In the event of any ties, duplicate awards will be given and Co-Champions declared. Prize money for ties will be combined and divided equally.
